OLD BUSINESS – REPORTS:

- 12. <u>Security</u>. Security breaches continue due to inadequate fencing surrounding Grounds Crew area and fencing bordering IHOP area. Current chain link fencing is continually being cut and/or used to climb to and from District property and does not deter criminal activity during vulnerable times. Fencing will be replaced ASAP to secure equipment, personnel and property.
- 13. <u>Hedges</u>. Planting will begin at entrance, in the fall. Discussion between vendor, staff and crew yielded a new and more productive trimming program. Crew is working closely with vendor for this project.

- 14. <u>Re-districting</u>. New small version of map was received (attached); District Manager is working with the Transportation Authority to arrange for a larger map that will replace the older version. District Manager is following up regarding agreements.
- 15. <u>Office Restructure</u>. More urgent projects of expanding the niche complex and installing security fencing have taken the lead position. Office restructure will be addressed as soon as possible.
- 16. <u>Jewish Cemetery</u>. There are very few Jewish cemeteries in southern California, which makes Home of Peace an important asset to the District. DM has asked for Rabbi Epstein's guidance to help the District improve where possible and better promote this asset. While waiting for Rabbi Epstein to return from an extended vacation, DM has researched the particular requirements/rules regarding Jewish cemeteries and is better prepared to work closely with the Rabbi in this endeavor, in addition to addressing the Rabbi's immediate concerns.
- 17. <u>Website</u>. The new website is up and running. DM has received training and accomplished the uploading of the agenda. More improvements and changes will be made in the next week.
- 18. <u>Replacement of Trees</u>. This project has been moved to our "winter" schedule when the grounds crew will be more readily available to assist.
- 19. <u>Completion of Second Half of Street Repair</u>. DM will be meeting with the contractor to determine the schedule of the final phase of the street repair project.
